STRATEGY FOR HIGHER EDUCATION, SCIENCE AND TECHNOLOGY (2008-2012)

Main Objective: Reforming and transforming higher education systems in Africa to energize and unlock the minds for brighter economic prospects.

It is to assist Regional Member Countries (RMCs) in (i) strengthening national and regional centres of excellence in the following selected priority areas: agriculture and livestock, health sciences and health delivery support services, engineering, business enterprise, training of teachers and educational managers; energy (ii) building and/or rehabilitating the existing science and technology infrastructure, including tertiary education institutions; and (iii) linking higher education, science and technology (HEST) to the productive sector.

5 Operational Strategies

- 1. Infrastructure Development;

- Takes an even more holistic approach and looks at the human capital implications for all sectors of development;
- Provides a framework for Bank's investments in human capital within the context of the Bank's 2013-2022 Strategy; and
- Building social protection systems has emerged as a foundation for the inclusive and green growth agenda

(Through New Education Model in Africa (NEMA) — helping create a new governance framework for education, focusing on innovation and entrepreneurship);

KENYA: SUPPORT TO THE ENHANCEMENT OF QUALITY AND RELEVANCE IN HIGHER EDUCATION, SCIENCE AND TECHNOLOGY PROJECT

Objective: To contribute to high-quality education and training in STI.

Total Cost: UA 36.03 Million



- Improving the quality and relevance of STI education programs;
- Strengthening human capital development for STI programs;
- Improving quality of applied knowledge and skills in environmental/natural resources management; and
- Enhancing MOHEST capacity for evidence-based policy formulation and program management.



UGANDA: Support to Higher Education, Science and Technology (HEST) Project

Objective: To improve equitable access, quality and relevance of skills training and research leading to job creation and self-employment

Total Cost: UA 74.44 Million



- Improving and expanding HEST in six public universities and two degree-awarding tertiary institutions;
- Building capacity in public HEST institutions;
- Improving quality and relevance of HEST in public institutions; and
- Project coordination



Malawi: Support to Higher Education, Science and Technology (HEST)

Objective: To increase access and improve the quality and relevance of HEST and TEVET.

Total Cost: UA29.45 million



- ICT for Skills Development and Employability;
- Increasing Access to HEST;
- Improving Quality and Relevance of HEST and TEVET; and
- Impact Evaluation, Development of Monitoring and Evaluation System and Project Management



CAPACITY BUILDING IN OPEN AND DISTANCE LEARNING PROJECT

Coverage: SADC Region through Centres of Specialization in Malawi and Tanzania

Objective: to contribute to regional integration through the development and deployment of effective, harmonised open and distance learning (ODL) in the SADC Region.

Total Cost: UA 15.00 Million



- 1. ODL Regional Policy Development and Strategic Planning; and
- 2. Capacity Building for Open and Distance Learning



African Virtual University (Phase II)

Objective: To strengthen the capacity of 27 Partnering Institutions (PIs) in 22 African countries within the AVU network and the African Virtual University (AVU) to develop, deliver and manage quality ICT assisted tertiary education and training opportunities in science and technology programmes.

Total Cost: UA 13.64 million



- 1. Establishment of ODeL Centres;
- 2. Training of PIs in ACEP and Development of ICT enhanced modules;
- 3. Enhancement of AVU Capacity; and
- 4. Project Management



PAN AFRICAN UNIVERSITY PROJECT

Coverage: Africa as Whole through Thematic Centres of Excellence

Kenya - Sciences, Engineering, and Technology **Cameroon** - Governance, Humanities and Social Sciences **Nigeria** - Life and Earth Sciences

Objective: To establish an academic network of already existing post-graduate and research institutions by supporting the Pan African University (PAU), and advance Africa's goal of enhancing its competitiveness and growth through the creation of high quality higher education and research capabilities.

Total Cost: UA 102. 83 Million (ADF UA 30.00)



- 1. Support to Science and technology programs;
- 2. Support to Governance and regional integration program; and
- 3. Support to PAU Administration and Project Management.



Support to a Network of African Institutions of Science and Technology Project

Region - ECOWAS

Objective: to increase the number and improve the quality of qualified science and engineering graduates in the ECOWAS region in order to provide a regional consolidated response to the needs for highly qualified personnel in science and engineering in the ECOWAS region.

Total Cost: UA 12.00 million



- 1. Facilitating regional and institutional networking;
- 2. Improving relevance of training and research; and
- 3. Project Management



Observations for RISE

- 1. Activities for the Bank have synergies with those of RISE;
- 2. There is scope for harnessing the synergies and build collaboration;
- 3. A formal relationship between the Bank and RISE may facilitate collaboration between the two; and
- 4. Tapping on existing RISE's relationship frameworks with Regional Economic Communities (e.g. SADC), the World Bank and African Union may facilitate collaboration with the African Development Bank.
